All services provided under a single license are considered B2C (Business-to-Consumer), although B2B providers may also apply depending on their business model.





Corporate Requirements

Applicants must register a legal entity in Anjouan or another approved jurisdiction (such as Belize or St. Lucia). A local representative or liaison may be required by the licensing agent.

The GL Team will introduce a trusted Corporate Service Provider (CSP) who will coordinate in fulfilling these requirements, including company incorporation and registration.

Compliance Requirements

Anjouan requires basic AML and KYC procedures to be in place. While the framework is not as demanding as in tier-1 jurisdictions, licensees must maintain sufficient documentation and records to ensure compliance with general international standards.


Technical Requirements

Operators must show they have a functioning platform, secure data handling, and an operational website ready for commercial launch. There are no on-island hosting requirements.

Responsible gaming policies

Operators must implement basic responsible gaming measures, including age verification, account limits, and player exclusion features.

Corporate Setup

Setting up an Anjouan company with a resident Managing Director for the first year is approximately **EUR 5,000.** This includes essential services to get your business off the ground. Ongoing annual renewal is approximately EUR 1,950 and covers office rental. Alternatively, you can opt to incorporate a Belize company to hold the license, with setup and annual renewal fees each at EUR 1,100. Regardless of the jurisdiction you choose, be sure to factor in additional costs for administration, time investment, and any activity-based charges.

License Fee

The annual gaming license fee is EUR 18,000 and includes:

Anjouan Internet Gaming License, AML filing fees, compliance & due diligence fees, KYC filing fees, and License management platform fees. License fees are for 12 Months and include Key Person Authorization fees.

Two URLs are included. Each additional URL is **EUR 500.**

Additional Costs

There may be additional costs for registering new domain names or amending the license to accommodate changes such as updating directors or beneficial owners.
