Global Market Access

A Nevis gaming license allows operators to access multiple international markets, particularly in Asia, Latin America, and parts of Africa, though not suitable for restricted or blacklisted jurisdictions.

The following markets are considered restricted / prohibited and forbidden by the license and must be GEO IP Blocked:

Australia, Austria, France, Germany, Netherlands, Spain, St. Kitts & Nevis, United Kingdom, USA, FATF Blacklisted Countries, Sanctioned Countries and/or any other jurisdiction that the Nevis Online Gaming Authority deems online gambling as prohibited.

2. Nevis Online Gaming License Types

The duration of the Nevis Online Gaming License is one year and can be renewed annually.

Nevis currently issues a general B2C gaming license that covers a broad range of services, including:


Online casinos

Sports betting

Poker and table games

Lottery and skill-based games

B2B licenses are also available and white label services require both a B2B and B2C licenses, in addition to specific approval which is considered on a case-by-case basis.



3. Key License Requirements

• Corporate and Substance Requirements

Applicants must incorporate a company in Nevis under the Nevis Business Corporation Ordinance, which is equivalent to an International Business Corporation. A Director is required and can be provided if necessary. The company needs to have a Nevis address with a registered agent and a Local Reporting Officer.

GL will facilitate the incorporation of the company and legal address along with compliance checks and corporate services moving forward. Additional back-office services are available upon request.

→ Financial and Compliance Requirements

Applicants must demonstrate adequate capital to support their operations and provide a Business Plan, Financials Statements, Source of Wealth/Funds documentation and proof of domain ownership, compliant Terms and Conditions among other documentation. back-office services are available upon request.





• Technical Requirements

Operators must present a functioning website or platform, adequate server infrastructure, secure transaction capabilities, and protection for user data. Copies of Independent RNG Testing Certificates and Copies of Game/Content provider agreements for gaming systems and games used are also required where applicable.

• Responsible Gaming Policies

Applicants are expected to include KYC, Responsible Gaming, Underage Gaming, and AML Policies in order to be compliant.

4. Application Process and Timeline

Application Submission

Applicants submit business details, corporate documents, platform specifications, and compliance policies. GL assists with preparation and coordination.

Review and Due Diligence

Nevis authorities and registered agents review all submitted materials. Due diligence includes background checks and verification of the business model.

License Issuance

Licenses are typically issued within 8 to 12 weeks following the submission and approval of all required KYC documentation.



5. Fees and Associated Costs

— Corporate Setup

Formation of a Nevis company to serve as License holder is EUR 3,000 and includes first year costs of the registered agent and office fee. Annual renewal costs vary but are generally in the same range.

Gaming License Fee

Total initial costs for the standard B2C license is approximately EUR 38,700 and includes two domains, the required Local Reporting Officer costs as well as fees for preparing and managing the application process. Additional fees may apply depending on the scope of the license or if multiple domains or verticals are included.

Additional Costs


Additional costs include:

- Domain registration fees
- Director changes or shareholder updates
- Third-party testing or compliance tools (if required by banks or payment processors)
