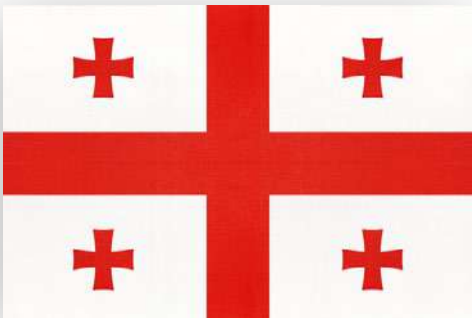

General (Master) E-Gambling License

The **General (Master) E-Gambling License** is a premium license that allows the holder to operate multiple sub-licenses for third-party operators. This is ideal for businesses looking to expand their operations and offer licenses to other companies under their jurisdiction.

Eligibility Requirements for Master License

To qualify for the **Master License** in Georgia, companies must have a **Georgian-based company**. This is a crucial requirement for entities wishing to operate at the highest level in Georgia's licensing framework. While this adds an additional layer of responsibility for the operator, it also provides enhanced control and governance over their operations.

Timeframes for License Issuance

- **Ordinary E-Gaming License:** 4 to 6 weeks
- **General (Master) E-Gambling License:** 6 to 8 weeks

Costs

- **Sub-License:** EUR 56,000
- **Master License:** EUR 86,000 (only 4 remaining)
- **Sub-License for Master License Holder:** EUR 41,000
- **Nominee Director for Master License:** USD 15,000 per year



Key Steps to Obtain a Gambling License

- 1. Register a Business**
You must establish a **Georgian-based company**. Citizenship is not required, but the company must be registered in Georgia.
- 2. Open a Bank Account**
Open a **business bank account** in Georgia to manage financial transactions, including deposits and payouts.
- 3. Prepare Company and Gambling Information**
Gather details about your company, the **types of games** you plan to offer, and your **payment conditions**.
- 4. Submit the Application**
Apply online for the **Georgia gaming license** with the prepared documentation.
- 5. Pay Mandatory Fees**
Ensure that all **required fees** are paid on time for application processing.



Requirements

- **Georgian Company:** Must be a locally registered company, but citizenship isn't required.
- **Protection of Minors:** Demonstrate measures for preventing underage gambling.
- **Operational Data:** Submit information about your business, gambling activities, and payment methods.
- **Business Address:** Prove a valid business address in Georgia.
- **Ability to Pay Winnings:** Show your financial capacity to pay out winnings.
- **Timely Fees:** Ensure taxes and fees are paid on time.

Documents Required

1. Certificate from the State Register of Legal Entities
2. Gambling Terms and Conditions
3. Game Descriptions
4. Company Chart
5. Proof of No Criminal Record
6. Layouts of Gambling Equipment (if applicable)
7. Business Legalization Application
8. Proof of Registration Fee Payment

Additional documents may be requested depending on your case.
